Dakota: Update on the proposed new Recycling Zone Plus facility. Dakota County anticipates building a new regional HHW and recycling drop-off facility in Lakeville. The new facility will be a partnership with Scott County to provide additional services to residents in both counties.

Kristi Otterson is a Sr. Environmental Specialist at Dakota County Environmental Resources Department and has been the HHW program manager for 5 years. She has worked for Dakota County since 2012 and has over 23 years in public and private solid waste and hazardous waste management.

Stearns: Stearns HHW continues to evolve and is making radical changes. They discuss the considerations and decision making behind program expansions, staffing, mobile collections, and facility hours.

Mike Rogers graduated from SCSU in 2017 and began working for Stearns County that summer. He is now a Senior Environmental Specialist and is passionate about safety and exploring new ideas for the county.

Sherburne: HHW mobile events have proven unsustainable for Sherburne County's growing population. Sherburne County contracted with HDR Inc. to complete a household hazardous waste feasibility study to assist the County in planning for the future of HHW management. As a result, Sherburne County is moving forward with plans to construct a permanent HHW facility to better manage this growing waste stream.



Maureen Mossak is an Environmental Specialist with Sherburne County. With a deep commitment to waste reduction, she works to develop strategies that minimize waste, promote recycling and foster sustainable practices. She is responsible for assisting in the development of County solid waste policies and programs, coordinating household hazardous waste collection events, working with schools to implement waste reduction and recycling programs, as well as, enforcing County ordinances. She received a Bachelor of Science degree from The University of Minnesota and has over six years of diverse experience in supporting waste reduction and recycling initiatives.

Jillian Carlson works as an Environmental Specialist for Sherburne County, working to provide robust recycling programs for county residents and local businesses. She has worked at the county for three years, during that time working to put her passion for environmental sustainability into action by researching, developing, and implementing solid waste strategies that focus on enhancing recycling waste reduction efforts, as well as, maximizing landfill abatement ultimately to protect the county's land, air, water and other natural resources and public health.
